Dues Level Descriptions & Dues Amounts FY2024

Social Level

Includes unlimited Member* access to the pool, fitness center, dining venues and social activities. Fitness classes are available at an extra cost (See User Fee Schedule.) There is no access to golf, tennis or pickleball for Members, or their guests, at this Level.

Property Owner - \$2,725
Former Property Owner/Non-Property Owner - \$2,850

Sports Level

Includes unlimited Member* access to everything (pool, fitness center and classes, dining venues, social activities, tennis and pickleball) except golf. Daily golf play is available at Sports Level member rates.

Property Owner - \$3,250
Former Property Owner/Non-Property Owner - \$3,390

Single Golf Level

Includes Sports Level amenities (pool, fitness center and classes, dining venues, social activities, tennis and pickleball), plus unlimited greens fees for one (1) designated Member. Spouse and unmarried dependent children age 22 and under will default to a Sports Level Membership.

Property Owner - \$5,975
Former Property Owner/Non-Property Owner - \$6,275

Full Golf Level

Includes Sports Level amenities (pool, fitness center and classes, dining venues, social activities, tennis and pickleball), plus unlimited Member* greens fees.

Property Owner - \$7,425
Former Property Owner/Non-Property Owner - \$7,800

*Member is defined as the designated primary member, their spouse and unmarried dependent children age 22 and under.
